Dear Chairman Kennedy and Ranking Member Enzi:

As you and your colleagues continue to work on health reform, the over one hundred undersigned coalitions, groups, and organizations urge your support for addressing health inequities among underserved communities and populations, and ensuring the safety and quality of health services for all. We respectfully request a hearing to discuss opportunities within health reform to ameliorate and eliminate the grave disparities in health status and health services.

Striking disparities in health status exist among various communities and populations throughout the United States, which include shorter life expectancy, higher rates of chronic health conditions, and disability. According to the Agency for Healthcare Research and Quality (AHRQ), disparities are also observed in most aspects of health care, including care for chronic conditions such as mental health disorders and substance use, HIV/AIDS, cancer, diabetes, heart disease, stroke, oral health conditions, infant mortality and morbidity, respiratory disease, and end stage renal disease.

The undersigned organizations recognize that comprehensive health reform is essential to improving the safety and quality of health services, and will help to improve the health of everyone in our country. As the United States continues to struggle with how to improve health equity and ensure that all have access to culturally and linguistically appropriate health services, we urge you to seriously address this issue in health reform and convene a hearing.
