Have not received any School Registration Papers - Per Dr. Sullivan, "Dad SHOULD COMPLETE THE FORMS AND GIVE THEM BACK TO Mom TO SUBMIT. SHE CAN MAKE A COPY IF SHE WOULD LIKE TO." [see attached Hearing and Fall Soccer]

I have these papers to hand off on Monday 8/17.

Have not received any School Calendar - Per Dr. Sullivan, "Dad, CAN YOU PROVIDE A DRAFT CALENDAR TO DAD BY THE END OF THE MONTH [July] FOR SEPTEMBER-JUNE WHICH CALENDARS THE REGULAR SCHEDULE HOLIDAYS AND VACATION PERIODS ACCORDING TO THE PARENTING PLAN. DAD CAN THEN REVIEW AND COMMENT BY 8/10 AND ANY UNRESOLVED ISSUES WE CAN HANDLE IN OUR MEETING ON 8/20." [see attached Hearing and Fall Soccer]

Please note that there were some errors in the pass calendar, which I adjusted most notable:

Also....4/12 is a school day not a holiday

Have not received copy of the pre-registration forms for children - I inquired about the process for determining if child was to be a "morninger" or "afternoonner" for Pre-K as we had to put in a request last year with Child #2 early in the summer after discussion with Dr. Sullivan that I made on the family's behalf. I learned from the school that I should consult with you as you already turned in the form and the school administrator who is managing the forms is off on vacation currently. As I did not receive a copy of this application, would you provide a copy of the Pre-K application and did you pick a time preference for Child? I would like to put in a formal request this week, as the school district resident, for child to be a morning person as soon as you can get me a copy of the form that I can update. Will you be able to provide to me by Friday morning?

I will remind you that the only paperwork I filled out was a request for Child #3 related to a teacher request (more focused on not getting Ms. Teacher) which I shared with you verbally before handing in, which you agreed to at that time.

I did not make any additional requests or fill out any additional paperwork.

Family Calendar appointments in limbo—Never received an email response to the attached email on Family Calendar. The Family Calendar shows a drop off at 5pm at my home, but in the Subject it says drop off is 8pm on Saturday, 8/15, for transition. Will I have the children for dinner at 5pm or after at 8pm?

Updated.

I did not receive an acknowledgment/ response to: Response and Questions: Batched Email July 12.

I have not received any report from Child #3's summer school or speech pathologist, did you? If so, would you pass along? If not, I will request feedback from the school.

I did not receive anything from the school.

Missing Clothing: Child #1's red polo shirt- (returned) Child #2's fleece pink zip up hoodie, child #3's lime green tank top.(Have searched and have not seen either-if they turn up - will let you know) I am currently missing a blue fleece "North Face" zip up for Child #1. Missing various bows/hair accessories if you have them around.

Children Activity for the Fall:

Child #1 is registered for soccer (I am coaching) and received from the head coach over the

weekend when in training the practice times and AYSO posted game times, which I will post into the FC. I will register Child #1, as previously agreed upon, for Flag Football (which I will not be coaching) which takes place on Sundays, 10/4 - 12/6 (except 10/12, 11/29) for \$125. **I need to speak to Child #1 prior to your registering him. I see from the web site, it is on Sundays from 1-5 for 9 yr. olds. I agreed to support last season's flag football.

child #2 - soccer is cancelled. I recommend that we enroll her into gymnastics (at The Little Gym in Town for Monday and Thursdays, which begin on Aug 24 for 20 weeks for \$395) and/ or dance Jazz/Hip-hop beginning 9/12 - 12/12 at the Rec Center for \$142. I will discuss with child #2 her desires and of course must take into consideration my financial capabilities.

Child #3 - soccer is cancelled. I recommend that we enroll her into gymnastics.

Again, I will speak to Child #3 and filter into financial considerations.

child #4- soccer is registered. The games times are posted on AYSO website and I will put into the FC. I am coaching. Is there an update on Brownies/ Rainbow enrollment for the girls? The only ability to currently have the age appropriate girls in brownies is if I become a brownie leader. I spoke to the last leader about the time needed for this job. I would not be able to provide leadership in this area. I will investigate other options and see if someone else would like to start a troop, but at this time, the enrollment is on hold pending troop formation.

Child #4's Insurance EOB for dental when you brought her is attached for your reference. What is the status of the mouth plate? Given she had 3 loose teeth, the dentist will see her in a few months. As you know, I just purchased a "Thumbuster" and Child #4 is very excited about it.

She has been three full days without her thumb and she is proud of herself...hence her email to you. The hardest times for her are at bedtime and morning time...I have been cuddling her at night and try to engage her in activity when she rises in the morning. I mentioned to Babysitter last Thursday, that she has Athlete's Foot between her toes and I am treating with an oil for that purpose. I have attached to be share the kids' activities from family reunion, X Museum and daughter's godfather

I noticed that you have pre-programmed phone numbers into Children's cell phones and "his friend" X is in the list. This is the "X" that I was asking you about a few months ago....you said you did not know who X was so, Who is X and his family?
