

PsycTESTS Agreement

This Agreement is between _____ (“Test Author”) and the
American Psychological Association (“APA”) and is effective as of _____, 201____.

1. Test Author grants APA an irrevocable, non-exclusive, royalty-free, perpetual license to reproduce, distribute, and publicly display the original test or measure listed below (“Test Content”) now or in the future as contemplated herein. The Test Content may have been previously published in whole or in part as a portion of a larger work in a journal or book (“Work”), and if so, I warrant that I have a right to republish the Test Content since it is a portion of my prior published Work.
2. APA owns all right, title and interest in the electronic database, PsycTESTS, a searchable electronic database for tests and measures. Nothing in this agreement shall convey to Test Author any rights in PsycTESTS.
3. The license from Test Author referenced in Paragraph 1 shall include an irrevocable, non-exclusive, royalty-free perpetual license to APA to create citations and abstracts (“Summary Content”) of the Test Content for APA’s PsycTESTS database and to include these in the PsycTESTS database together with the full text of the Test Content. APA shall own all right, title, and interest in Summary Content.
4. Test Content and any Summary Content created by APA and stored in the PsycTESTS database may be distributed in any media worldwide in the PsycTESTS database.
5. APA shall provide full credit to the Test Author for all Test Content the author provides to APA for inclusion in the PsycTESTS database and PsycTESTS shall link to related articles published under the author’s name, as well as to related records in PsycINFO.
6. Test Author agrees to indemnify, defend, and hold harmless APA for any claims of intellectual property infringement brought by any third party based on the use of third party materials in the Test Content.
7. Test Author represents and warrants that the Test Content is original and non-infringing upon any third party’s rights and that all necessary permissions to use any third party materials incorporated in the Test Content have been obtained.
8. Test Author verifies that the Test Content has not been published commercially (**please check the box if the statement is true**).
